Town of Winnipeg Beach BY-LAW # 6/2016

BEING A BY-LAW OF THE TOWN OF WINNIPEG BEACH to provide for the regulating of municipal cemeteries.

WHEREAS the provisions of the Municipal Act, R.S.M. 1996, c.58 provides in part as follows:

Spheres of jurisdiction

- 232(1) A council may pass by-laws for municipal purposes respecting the following matters:
 - (a) the safety, health, protection and well-being of people, and the safety and protection of property;
 - (b) people, activities and things in, on or near a public place or a place open to the public, including parks, municipal roads, recreation centres, restaurants, facilities, retail stores, malls and private clubs and facilities that are exempt from municipal taxation;
 - (c)

AND WHEREAS the Council of the Town of Winnipeg Beach deems it expedient and in the public interest to regulate the municipal cemetery located on 3--15446 ORG NE 28-17-4E (R.M. of St. Andrews).

NOW THEREFORE, the Council of the Town of Winnipeg Beach, in Council assembled, enacts as follows:

- That the price for each lot or plot shall be as set in the Town of Winnipeg Beach Fees By-Law the said funds to be held and set apart by the town and retained in a special account;
- That the funds received from the sale of plots can be collected by the town or its agent;
- 3. That the funds received from the sale of plots shall be used to offset the costs of improving, caring for, and beautifying the cemetery grounds.
- 4. That the maximum number of burial sites on a plot is limited to a maximum of one (1) casket and four (4) cremations.
- 5. That the funds established, set aside and maintained from the funds referred to in Sections 1, 2 and 3 including the income from investment of such a fund, shall be used for the perpetual upkeep and care of the cemetery as recommended by the Protective Committee but the expenditure of such funds shall be subject to the approval of Council;
- That no burial will be allowed or is to take place without notifying the town or its agent.
- 7. That no headstone or individual markers will be installed without the permission of the town or its agent first having been obtained.
- That the town shall have the right to remove any broken material, excess growth, or other material which, in the opinion of the majority of the members, is distracting from the appearance or the maintenance of the cemetery;
- 9. That Blocks 7, 8, 15, 16, 23, 24, 31, 32, 39, 40, 47, 48, 55, 56, 61, 62, 69, 70, 77, 78, 85, 86, 93, 94, 101, 102, 107, 108, 113 and 114 in the Winnipeg Beach Cemetery, be set aside for the descendants of the donor of the Cemetery (Mr. Gislason), as arranged by the late Mr. W. Thompson. This is as per Council Resolution November 12, 1954 and as set out in Cemetery Committee Minutes dated August 19, 1997.
- 10. That By-Law 5/2014 is hereby repealed.
